

CONSENT TO PERSONAL DATA PROCESSING

I hereby, hereinafter referred to as the "Personal Data Subject", in pursuance of the requirements of Federal Law No. 152-FZ of July 27, 2006, No. 152-FZ "On Personal Data" (with amendments and additions) freely, of my own free will and in my interest, give my consent to JSC "Publishing House "Gudok" (TIN 7701660262, 105066, Russia, Moscow, Staraya Basmannaya street, 38/2, building 3) for the processing of the following personal data: surname, name, patronymic; date and place of birth, citizenship, education, address, profession, contact details (phone, fax, e-mail, postal address) specified during registration by filling out the web form on the website <http://railwayforum.ru> (hereinafter referred to as the Site) sent (filled in) via the Site.

I consent to my personal data processing by the society, that is, to perform, among other things, the following actions: processing, collection, systematization, accumulation, clarification, updating, change, use, distribution, transfer, including cross-border, depersonalization, blocking, destruction, indefinite storage, while a general description of the above data processing methods is given in the Federal Law of July 27, 2006 No. 152-FZ, as well as the transfer of such information to third parties, in cases established by regulatory documents of higher authorities and legislation.

In order to register the Personal Data Subject on the Site with the subsequent sending to the Personal Data Subject of mail messages from JSC "Publishing House "Gudok", as well as to confirm the identity of the Personal Data Subject.

The date of consent issue to the processing of personal data of the Personal Data Subject is the date of sending the registration web form from the Site.

The processing of personal data of the Personal Data Subject can be carried out using automation tools and/or without using automation tools in accordance with the current legislation of the Russian Federation and the internal regulations of JSC "Publishing House "Gudok".

JSC "Publishing House "Gudok" takes the necessary legal, organizational and technical measures or ensures their adoption to protect personal data from unauthorized or accidental access to them, destruction, modification, blocking, copying, provision, distribution of personal data, as well as from other illegal actions in relation to personal data, and also undertakes the obligation to maintain the confidentiality of the personal data of the Personal Data Subject.
